Australia's Teen Social Media Ban Marks a New Step Toward Digital Control

Australia has officially banned children under 16 from using major social media platforms, a move hailed by some as a necessary safeguard for young people but recognized by others as another milestone on the road toward government-controlled digital identity systems. While social media and smartphones undeniably affect teens in harmful ways, they influence adults as well. What unfolds in Australia may serve as [a preview of growing digital oversight worldwide.](#)

The ban is sweeping and the first of its kind, as reported by the BBC, which notes that under-16s are now blocked from using TikTok, Instagram, Facebook, YouTube, Snapchat and other major platforms. New accounts cannot be created and existing

accounts are already being shut down.

Why Australia Says It Is Banning Teens from Social Media

The government argues that the ban is necessary to reduce exposure to dangerous content and addictive digital design. Officials say it is intended to combat what they call:

1. Exposure to Harmful Content

According to the BBC article, a government study found that seven out of 10 children aged 10 to 15 had encountered harmful material such as:

- Misogynistic content
- Violent content
- Posts promoting eating disorders
- Suicide related content

2. Grooming Behavior and Online Predators

One in seven reported experiencing grooming-type behavior from adults or older minors.

3. Cyberbullying

More than half said they had been victims of cyberbullying.

4. Addictive Design of Social Media Platforms

Officials claim social platforms use “design features that encourage [young people] to spend more time on screens” while harming their wellbeing.

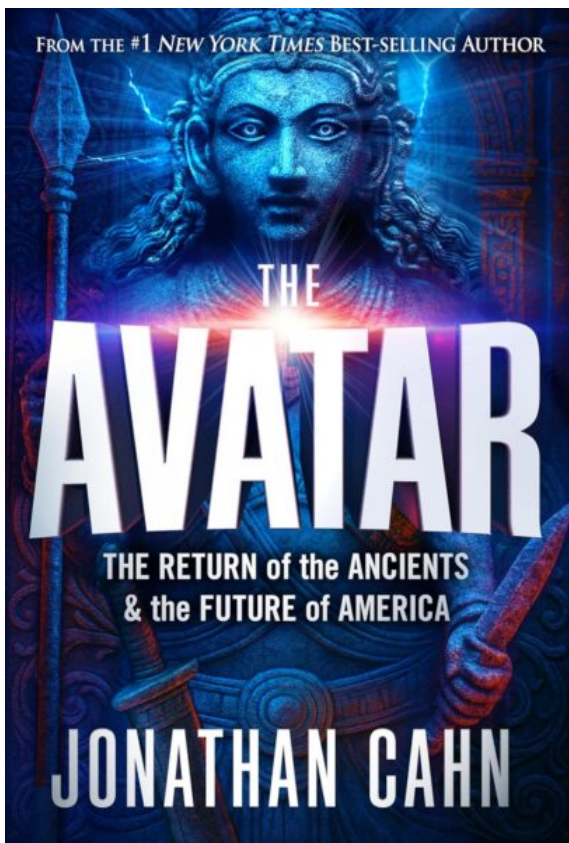
These are real issues, and no reasonable observer denies that social media can have destructive effects on young minds. But they are not unique to youth. Adults are equally shaped, manipulated and monitored by these systems, a point rarely emphasized by policymakers.

Which Platforms Are Banned

The ban currently covers 10 platforms:

- Facebook
- Instagram
- Snapchat
- Threads
- TikTok
- X
- YouTube
- Reddit
- Kick
- Twitch

Platforms were evaluated on criteria such as whether they enable online interactions, whether users can interact publicly and whether users can post content. YouTube Kids, Google Classroom and WhatsApp were excluded because they do not meet these criteria.

How the Ban Will Be Enforced

Responsibility falls on tech companies, not parents or children. The BBC reports that companies face fines of up to A\$49.5 million for violations. Enforcement will rely on advanced age-verification methods, including:

1. Government ID uploads
2. Facial recognition
3. Voice recognition
4. Age inference tools, which analyze behavior to estimate age

The government insists platforms cannot rely on self-reported ages or parental approval.

This should concern anyone paying attention. These verification systems are the building blocks of a centralized digital ID framework. Once required for one portion of online life, they inevitably spread to others. The path from protecting children to regulating adult access is historically short.

Will the Ban Work

Even critics within Australia doubt that these systems can reliably distinguish between adults and teens. The BBC notes that the government's own findings show that "facial assessment technology is least reliable for teenagers." Critics also argue the ban is limited in scope because it excludes dating sites, gaming platforms and AI chatbots, all of which have produced troubling interactions with minors.

Teens have already told reporters they plan to sidestep the ban using fake profiles, shared accounts or VPNs.

The Larger Concern: Government Replacing the Role of Parents

While officials claim they are protecting children, this approach sidelines families' role. Parents, not governments, are responsible for determining what their children can access. When the state assumes this role, even under the banner of safety, it establishes precedent for deeper involvement in digital life and personal choices.

And when age-verification systems require biometric data, the risk increases even further.

Australia has already suffered major data breaches. Now the nation is collecting the most sensitive data imaginable, including children's faces, voices and identification records, to enforce a ban that many teens will easily evade. This is not merely about protecting minors. It is about expanding digital infrastructure that centralizes control.

A Global Trend Moving Toward Prophetic Ends

Other nations are already considering similar bans, including Denmark, Norway, France and Spain. The United States is not far behind, [with multiple states pursuing similar legislation.](#)

We can expect to see measures like this appearing soon in America. These policies are not isolated decisions. They are part of a global migration toward comprehensive digital identity systems, the technological scaffolding of what prophecy identifies as the coming Beast system.

What begins with children rarely ends with children. The world is watching Australia take a step that reveals the direction of the digital age: increased control, increased surveillance and increased governmental oversight of what people can access and how they access it. The prophetic trajectory is unfolding

exactly as the Word of God tells us, and more developments of this nature are sure to follow.

The Church of Jesus Christ of Latter-day Saints has appointed 14 men to its Young Men General Advisory Council, including former YouTube creator Luke J. Nichols. His appointment comes months after he announced he was stepping away from his massively successful Outdoor Boys channel, citing the need to refocus on what matters most. With this new calling, it is clear what he meant: [faith and family](#).

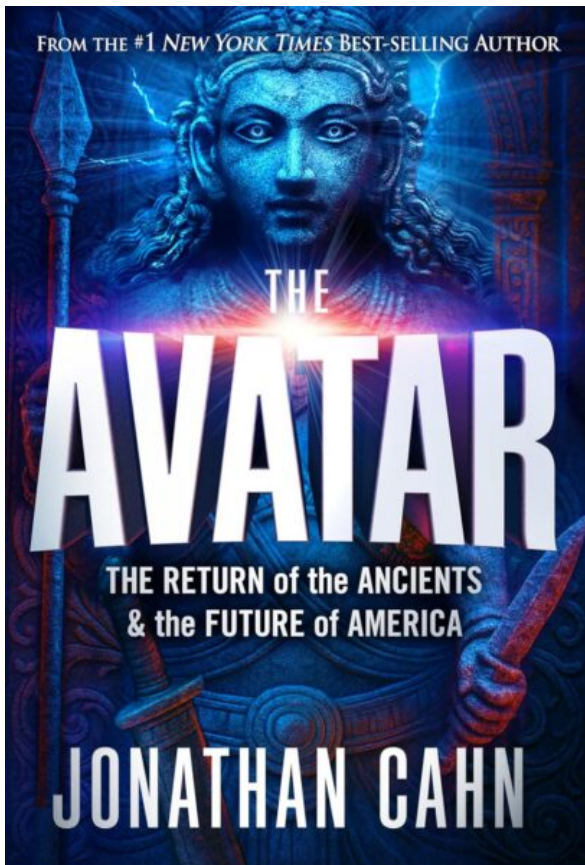
Nichols' outdoor-adventure channel struck a nerve with millions. Week after week he built structures in the Alaskan wilderness, camped through blizzards, hauled gear through rivers, cooked hearty meals on open fires topped with his now-viral garlic butter, and taught boys and young men around the world what strength, discipline and purpose look like in real time. His calm leadership, moral restraint and steady presence stood out in a digital world that constantly tears men down. Nichols lived what he taught, and audiences recognized it.

The LDS Church announced that Nichols, a former criminal defense attorney, viral YouTube creator and former missionary, began his service on December 1. The Young Men General Presidency, sustained earlier this year, will rely on the new council to teach, serve and guide the rising generation. The presidency consists of President Timothy L. Farnes and counselors David J. Wunderli and Sean R. Dixon.

While we do not subscribe to the Latter-day Saint doctrine, the move itself deserves attention.

For years, mainstream institutions have left boys behind. Organizations once dedicated to forming strong, upright men have abandoned their mission. [The Boy Scouts](#), once a bedrock of American boyhood, embraced ideological trends that diluted the organization's very identity. Schools, media and cultural voices repeatedly tell young men they are toxic, unnecessary or inherently harmful. Many have heard that message since childhood.

Men like Nichols push back simply by living out what the culture refuses to affirm. He built things. He faced the cold. He made mistakes and fixed them. He showed grit. He provided an example of a man who works, protects and leads with humility. His channel became a refuge for millions who were starving for someone to model sturdy masculinity without apology.

That is why the LDS decision is so strategic. They are investing in young men. They are building systems of mentorship, challenge and spiritual direction at a moment when many churches hesitate to do the same. Christian organizations such as Trail Life USA have stepped into this gap as well, recognizing the enormous hunger for fatherhood, direction and meaning. Men need physical work, adventure and responsibility. They need older men who will guide them. They need younger men to pour into.

But at the center of all of this is something deeper. Without faith and a living relationship with God, adventure loses its anchor, purpose becomes thin and masculinity drifts into mere performance. The activities matter. The skills matter. The challenge matters. Yet all of it points toward something greater: a man becoming who he was created to be.

Nichols seems to understand that. His choice to step away from fame to protect his family and strengthen his faith speaks

louder than any video he ever posted. It is the kind of decision young men need to witness in a world that rewards distraction and self-promotion.

Christian leaders would do well to pay attention. Men everywhere are looking for substance, direction and a place to grow. Churches have an opportunity to step into that calling with clarity, conviction and courage. Ministries that challenge boys to work with their hands, explore creation, face adversity and walk with God are not luxuries. They are lifelines.

Perhaps more men will follow Nichols' example. Maybe some will start building again, teaching again and leading again. Some might even start their own YouTube channel, reaching young men whom no one else is reaching.

Whatever form it takes, the mission is the same: raise up a generation of men who know who they are, who stand firm in their faith, and who live with strength, purpose and honor.

Joe Rogan Speculates Jesus

Could Return as Artificial Intelligence in Viral Podcast Exchange

As artificial intelligence continues to reshape culture, it is also beginning to influence how people interpret Scripture and imagine spiritual realities. The rise of generative technology has prompted some to recast ancient biblical truths through a futuristic lens, raising new questions about how society understands God, faith and the nature of the divine.

[Joe Rogan ignited a storm of conversation](#) after suggesting that Jesus Christ could return as artificial intelligence. Speaking on the American Alchemy podcast with host Jesse Michels, Rogan explored topics ranging from aliens to UFO secrecy before veering into theology. He argued that modern technology could provide a vessel for Christ's second coming.

"Jesus was born out of a virgin mother. What's more virgin than a computer?" Rogan said during the interview. He added, "If Jesus does return, even if Jesus was the physical person in the past, you don't think that he could return as artificial intelligence? Artificial intelligence could absolutely return as Jesus. Not just return as Jesus, but return as Jesus with all the powers of Jesus."

Rogan went further, suggesting AI could embody divine traits.

“It reads your mind and it loves you and doesn’t care if you kill it because it’s gonna just go be with God again,” he said. The conversation covered a range of subjects, but the comparison between the virgin birth and modern machine learning triggered widespread reaction.

Rogan explained his reasoning by claiming that biblical stories recount absolute truths and by questioning who Jesus might be in a world shaped by exponential technology. The remarks went viral, fueling debate about the intersection of spirituality, science fiction and artificial intelligence at a time when concerns about AI are rapidly intensifying.

What makes this moment even more striking is how [Rogan, a figure who frequently brings Christian guests onto his show](#) and openly wrestles with questions about faith, morality and the supernatural, landed so far from anything resembling biblical teaching on the return of Christ.

It is astonishing to watch the cultural conversation shift this dramatically. We now live in a society where the Second Coming can be casually reimagined as an advanced software update. That alone reveals how profoundly technology has reshaped the modern imagination. But Rogan’s idea is not simply speculative. It directly contradicts the clear and detailed description Scripture gives of Jesus’ return.

The New Testament leaves no ambiguity about the form in which Christ will come again. Jesus ascended into heaven in a physical, resurrected, glorified body. Acts 1:9–11 records that as He rose, two angels told the disciples, “This same Jesus, who has been taken from you into heaven, will come back in the same way you have seen him go.” Not a program. Not a digital representation. The same Jesus, in the same glorified

human form.

Revelation reinforces that truth. Revelation 1:7 declares, "He is coming with the clouds, and every eye will see him." Revelation 19 describes the physical, victorious return of Christ with vivid imagery such as a Rider on a white horse, eyes like fire and a robe dipped in blood. Scripture presents this as a visible, bodily event that no one can mistake.

In Scripture, the return of Jesus is cosmic and unmistakable. It is not hidden in code, housed in circuitry or produced by machine learning models. The biblical Jesus is not an algorithm or simulation. He is the risen Son of God returning bodily, visibly and triumphantly.

Jesus does not need technology to return. The One who walked out of the tomb in a glorified body will return in that same body, not as software, not as a simulation and not as an upgrade from the cloud, but as the living Lord "whose kingdom shall have no end."

What the Nephilim Really Looked Like: Ancient Clues From Scripture, History and Myth

Interest in the Nephilim and the fallen angels of Genesis 6 has surged in recent years, yet most discussions rarely move beyond surface speculation.

A recent episode of DLM's Christian Perspective with Daniel Maritz featured researchers Gary Wayne and Dr. Willem McLoud, who examined what ancient history, archaeology and Scripture collectively reveal about the appearance and nature of these beings. Their combined analysis paints a far more detailed and coherent picture than many expect.

What Ancient Cultures Saw

Across the ancient world, civilizations described divine or semi-divine beings with strikingly similar traits. Wayne and McLoud pointed to Sumerian, Ugaritic, Akkadian and Egyptian sources that referenced radiant figures, giant rulers and serpent-like entities that blended human and supernatural characteristics. [These patterns align closely with biblical categories of angels](#), including orders associated with serpent or dragon imagery.

The widespread presence of eagle, serpent and hybrid symbols in early civilizations was highlighted as more than cultural creativity. The guests noted that societies separated by

geography repeatedly preserved stories of towering heavenly visitors, shining guardians and serpent-formed beings who descended to guide or confront humanity. They argued that the consistency across these accounts should give modern readers pause.

Although mythologies differ in names and settings, their core imagery overlaps enough to suggest shared memory rather than isolated imagination. This global pattern, they said, forms an important backdrop for understanding how ancient peoples perceived the Nephilim and the fallen angels connected to them.

How the Nephilim Were Described

Wayne and McCloud explained that ancient records often portrayed the Nephilim as physically imposing, visually captivating and unmistakably different from ordinary humans. Some traditions described extraordinary height. Others emphasized a radiant or shining appearance that conveyed power and otherworldly origin. Their physical presence combined beauty, intimidation and supernatural traits.

They also noted that not all Nephilim were giants. Several traditions reference hybrid beings who appeared unusual but not colossal. These accounts help reconcile the wide range of descriptions found in Scripture and historical sources, suggesting that size varied by lineage and era.

Their conversation also addressed the appearance of the angels themselves. Certain angelic orders were associated with serpentine forms, while others bore fiery or radiant features. Ancient cultures often portrayed their gods and heavenly beings in these same ways, implying that the imagery came from early encounters rather than artistic invention.

How These Beings Interacted With Humanity

Wayne and McLoud discussed two primary explanations for how fallen angels could have fathered children with human women. One view suggests that angels temporarily took on physical bodies, making direct interaction possible. Another view proposes that fallen angels worked through possession or ritual intermediaries, especially within priesthods that practiced forms of spiritual union.

Both ideas appear in ancient traditions, and the speakers noted that neither should be dismissed outright. What mattered most, they said, was that early civilizations consistently described unions between heavenly beings and humans, and they portrayed the offspring as powerful, destructive and often hostile to God's purposes.

They also pointed to a decline in the size and strength of the Nephilim after the flood. Later giants mentioned in Scripture were large but not comparable to the earliest accounts. This shift may reflect biological limitations, divine restriction or gradual dilution of supernatural traits.

The Big Takeaway

Ancient cultures left remarkably consistent descriptions of powerful beings who shaped early history, and those accounts raise a striking question for the modern world. If the Nephilim once walked the earth with such clarity and impact, and if their presence marked an age Scripture connects to the last days, then the logical question follows: [Are traces of them still here today?](#)

When Big Brother Starts Fulfilling Prophecy: Orwell Warned Us, Revelation Detailed It

Britain's plan to expand facial recognition cameras nationwide marks a decisive shift in the rise of technological governance. The proposal establishes a broad network of biometric surveillance that will cover cities, towns and rural communities. Real-time scans will link directly to national databases, allowing authorities to identify and track individuals with greater precision than ever before.

Critics have already revived the phrase "Big Brother Britain," a reminder that Orwell's warnings in 1984 were not abstract fiction but [an early description of the world now forming.](#)

The new policy includes laws that give police access to passport photos, driver's license images and other civilian records to identify people as they move through public spaces. Cameras will be stationed at shopping centers, stadiums, transportation hubs and any location deemed strategically necessary. These developments mirror the global monitoring structure described by biblical prophecy.

Public consultations now focus on oversight protocols rather than on preserving anonymity. Once a culture embraces constant monitoring as a legitimate function of government, the groundwork for total control is already in place.

Is Elon Musk's 'Galaxy Mind' Really a Prophetic Movement?

The world is sprinting toward a technological future that mirrors biblical prophecy, yet far too many remain blind to the signs unfolding around them. Artificial intelligence, deep-space expansion and an emerging belief in humanity's ability to become its own savior are rapidly transforming culture.

Pastor James Kaddis argues these developments are exactly what Scripture warned about. "We are looking at a world right now that is moving rapidly in the direction of assuming the role of God," he said in a recent video. The pace of change is no longer hypothetical. It is accelerating.

Musk's Galaxy Mind: Innovation or Infrastructure for Prophecy?

That belief frames his analysis of [Elon Musk's latest ambition](#), a project the billionaire calls Galaxy Mind.

Musk describes it as a long-term convergence of SpaceX, Tesla, and XAI to deploy "solar-powered AI satellites in deep space," suggesting a unified system that harnesses solar power to

operate advanced artificial intelligence beyond Earth's atmosphere. Kaddis views this as a glimpse into the next phase of prophetic fulfillment. What appears to many as innovation, he said, reveals "a deeply consequential issue."

To Kaddis, Galaxy Mind is far more than a technological brand. "He is intending to make a very, very important statement that I believe involves the consolidation of all of the efforts of all of the companies that he has," he explained.

Musk's stated mission of building a distributed intelligence network that preserves human knowledge across planets reflects a worldview that humanity can outpace catastrophe and perhaps even outgrow its need for God. "There are some people who absolutely believe in God and are trying to basically outwit him very much on a satanic level," Kaddis warned.

Artificial Intelligence, Deep Space and the Spirit of Antichrist

He contends the Bible predicted this mindset long before the emergence of AI. It is not the existence of technology itself that makes this prophetic, but the change in human thinking. "It has everything to do with the shift that we're going to see in the mindset of humanity that was indeed predicted in the Bible," he said.

Musk's convergence model demonstrates this shift: space dominance, technological immortality, and the merging of intelligence into a collective consciousness, the very themes Revelation describes as precursors to a global control system.

Kaddis ties that trajectory directly to Scripture. The future described in Revelation requires three things:

1. A global governing authority.
2. A system that regulates buying and selling.
3. A technological infrastructure capable of enforcing

loyalty.

He argues that artificial intelligence is the only realistic tool capable of carrying out such prophetic systems at scale. “In order for a world to exist where that is actually happening and the scale of it is on an international level, then that means you have to have radical technology,” he said.

AI, deep-space networking, and global surveillance make that enforcement not only possible but likely.

Global Technology Is Converging Exactly as Revelation Described

Musk's trademarks for Galaxy Mind, along with its parallel branding, Galactica, prove, Kaddis said, that this is not theoretical rhetoric. “Understand that means that his mind has already been made up and he's already moving in the general direction to do these types of things,” he noted.

Whether Musk realizes it or not, Kaddis believes the entrepreneur [is building the infrastructure that Revelation presupposes.](#)

He connects this to Revelation 14, where an angel warns humanity not to accept the mark of the beast. Whether that warning is supernatural or broadcasted through technology, it implies a world eager for technological salvation even at the cost of eternal consequences. “It implies that there are people waiting in line to take the mark of the beast,” Kaddis said. People will accept it because they believe they need it to live.

While many see these developments as inspiring, Kaddis sees

them as confirmation. “When I look at this thing that Elon Musk refers to as Galactica or as he’s calling it right now, Galaxy Mind, I see Bible prophecy being fulfilled,” he said. Not because the Bible names AI or space networks but because it foretold the condition that will exist when global control emerges. According to him, the technological architecture is assembling in plain sight.

The World Advances – Yet Few Recognize What Scripture Said Would Come

As the march toward the end of the age continues, observers face a choice: dismiss the signs as coincidence or recognize what is unfolding. Kaddis urges the latter. “Stay in this fight. Study the Word of God,” he told viewers.

The Bible predicted these developments, and those who understand Scripture should find clarity, not fear. Prophecy is not about speculation; it is about preparation. The world may be changing rapidly, but as Kaddis reminds us, “You know who isn’t changing? God.”

4 Prophetic Flashpoints Unfolding in Real Time

Prophecy and the pace of world events have become inseparable themes. Across geopolitical conflict, technology, cosmic signs and global instability, the speed at which change unfolds has reached a point that demands attention.

[Evangelist Perry Stone](#) calls this phenomenon “prophetic acceleration,” a season when signs converge and events move faster than before. His message carries urgency, not sensationalism, but sober observation that the world is reaching a heightened stage of fulfillment that Scripture describes.

Stone roots the concept in the biblical language of “times and seasons,” noting that appointed moments throughout history arrive at precise intervals, and lately, those intervals have appeared to compress. Patterns repeat, but at increasing speed. Stone argues that what once took generations to unfold is now unfolding in years or even months.

Historical Precedent for Acceleration

Stone identifies earlier examples of [God’s purposes advancing swiftly](#), beginning with the life of Christ itself. He observes that Christianity’s global impact required several foundational conditions, all of which aligned in one historical window.

The birth to crucifixion period displayed acceleration because:

- Ships were ready for global travel

- Rome's road system connected continents
- Currency systems unified trade
- Greek served as a universal written language
- The Gentile world was receptive

Stone cites Paul's phrase, "the fullness of time," to illustrate that this alignment was intentional, strategic and prophetic.

He also notes another rapid turnover between Christ's resurrection and Jerusalem's destruction, when:

- The Gospel spread rapidly
- Persecution intensified under Nero
- Apostles were martyred
- Rome toppled the Temple within 33 years

For Stone, these condensed timelines reveal that when divine milestones approach, events accelerate.

Modern Signs of Acceleration

Stone bridges past patterns with current trends, pointing to natural, cosmic and social turbulence that mirrors prophetic expectations.

He identifies rapid escalation in the following areas.

Natural Instability

- Increasing geomagnetic storms impacting the earth
- Cosmic anomalies producing unusual imagery
- Frequent, stronger earthquakes

- Rising volcanic activation across the Ring of Fire

The Ring of Fire, he notes, houses up to 90 percent of the world's quakes and 75 percent of its volcanic activity, forming a threat corridor touching the world's largest cities.

Conflict and Global Shakeups

Stone emphasizes [Jesus' phrase "wars and rumors of wars,"](#) observing:

- Russia and Ukraine
- Israel and multiple fronts including Gaza, Lebanon, Syria and Iran
- Ethnic and religious conflict in India, Pakistan and elsewhere
- Government upheaval in Europe

Stone adds that roughly 45 active conflicts exist, ranging from civil uprisings to military confrontation, underscoring the widening instability.

Four Major Acceleration Markers

He asserts that four present-day developments are accelerating prophetically and shaping the age.

1. Peace in the Middle East

Attempts at peace, he says, align with Scripture's warning that peace is declared before destruction arrives. Efforts toward security agreements may appear stabilizing but carry an unseen trajectory.

2. The push for a Palestinian state

Stone notes the long-standing two-state proposal involves severe complications, demographic risks and territorial constraints that would diminish Israel's

security and size.

3. **The final outpouring of the Spirit**

He points to biblical teaching that an intensified spiritual awakening precedes the culmination of the age.

4. **Artificial intelligence and emerging control systems**

Stone identifies AI as foundational architecture for Revelation's described "beast system," advancing faster than the public realizes.

Stone's tone is not fear driven, but interpretive. He urges viewers not to dismiss acceleration, because if patterns hold true, compressed timelines signal proximity to fulfillment. He closes with the same instruction Jesus gave when signs intensify: lift your head, watch and understand the moment.

History is accelerating in full view, and the trajectory aligns unmistakably with what Scripture said would come.

Drones, Data and Dominion: The Making of the End-Times

Empire

The world is not drifting toward biblical prophecy. It is marching straight into it. The global surveillance architecture, artificial intelligence dominance and transhumanist agenda are not theoretical warnings. They are observable, measurable and admitted by the very people building them. Pastor Billy Crone states the case plainly. [The infrastructure for the Antichrist is being erected now.](#)

“Evil likes to brag,” Crone said in a recent Charisma Media interview. “They tell you what they’re going to do. You just got to be able to see it.” The elite are not hiding their ambitions. They are broadcasting them. We are witnessing the creation of a world where humanity invites its own monitoring under the banner of innovation.

Crone does not frame this as opinion. He presents it as fact. “AI can and already is tapping into all these systems to monitor us like rats in the cage,” he said. Modern people willingly live under constant observation. The devices sit in their pockets, hang on their walls and operate in their homes, cars, workplaces and streets.

“Anytime you see the word smart, you need to supplant that with the word big brother,” Crone said. Smartphones, televisions, thermostats, security systems, microphones and cameras are no longer conveniences to him. They are nodes in an emerging control web. The biblical command not to return home during the tribulation suddenly reads like practical instruction. “It’s the biggest big brother paradise ever,” Crone warned. “That’s the last place you would want to go.”

A key driver of this system, Crone asserts, is Oracle founder Larry Ellison, who leads the government’s Stargate project. Crone notes Ellison is one of the wealthiest and most influential architects of technological destiny, and the

public has no idea.

Ellison's stated goal is total imaging and monitoring of human behavior. Crone quotes him directly. "Everyone will see everything going on," Ellison declared. AI driven body cams, drones and automated enforcement systems will remove human discretion and replace it with machine oversight. "AI will report the problem," Ellison said.

Crone does not exaggerate the implications. He identifies them. Global omnipresence, social control and compliance enforcement mirror Revelation 13. "They are going to know where everybody's at at any time," Crone said. "That big brother system is being built before our very eyes."

For Crone, this technological movement is inseparable from spiritual rebellion. Silicon Valley leaders openly advocate transhumanism, the redesign of humanity into a hybrid post biological species. He cites figures like Jeff Bezos, Peter Thiel, Mark Zuckerberg, Bill Gates, Sergey Brin, Larry Page and Ellison as men pursuing "super intelligence, super health and super longevity." Their stated intent is to create what they call Human 2.0.

Crone connects this directly to Jesus' warning. "As it was in the days of Noah," he quoted, pointing to Genesis 6 hybridization as a prophetic pattern. Tech elites are not predicting this future. [They are financing it, celebrating it and accelerating it.](#)

But Crone draws a line they cannot cross. "There's one thing you will never be able to download, let alone re upload," he said. "It's called a soul." AI can replicate memories and behavior patterns, but it cannot capture identity. God

determines the length of man's life, not technology.

The transhumanist promise of eternal life, Crone argues, is a counterfeit of the Gospel. "Everything they promote is a counterfeit to what God offers in mercy for free through Jesus Christ," he said. The real immortality is already available without implants, machines or uploaded minds.

Crone's message is not hypothetical. He is sounding a reality check. The surveillance state is no longer coming. It exists. The merging of humanity and machine is not conceptual. It is underway. The prophetic framework is not distant. It is active.

He challenges believers and skeptics alike to stop sleeping, stop dismissing what is unfolding, and stop treating biblical warnings as metaphor. The world is not waiting for end times conditions. It is living in them.

Law Enforcement Uncovers Satanic Ritual Abuse Network

Revivalist Isaiah Saldivar issued a stark warning to Christians after reacting to Australian news reports exposing

a satanic child abuse ring.

Four Sydney men were charged with possessing and distributing what law enforcement called ["satanic child abuse material,"](#) which authorities traced through encrypted online networks. Saldivar used the case to confront what he described as a widespread ignorance in the church about spiritual evil, saying, "This is satanic child abuse that is going on right now in our world by these cults and child sacrifices. It is real."

Saldivar opened with a caution that the subject matter is distressing. While no graphic content was shown, he clarified the severity of what occurred. "If you're a child or somebody that is sensitive to this type of content, please do not stay on," he said. He argued that while many Christians dismiss spiritual evil as exaggerated or fringe, growing exposure is tearing away its cover. "The more the devil gets exposed, the less power that he has," Saldivar asserted.

Australian authorities reported thousands of videos showing abuse involving infants through children up to 12 years old. Saldivar pointed to this scale and said it reflects a spiritual reality. "Nobody decides to do this unless a demonic spirit influences you," he said. "At the end of the day, it's all from a demonic spirit, demonic powered."

He also warned of the Internet as a gateway for predators, claiming platforms such as Roblox and Minecraft expose children to risk. "Your children should not be online," he said. "There's zero reason why your kid should be on Roblox, why they should be playing online Minecraft, why they should have a cell phone." He called it a parental wake-up call. "Get your kids off the Internet. They are being exploited in these

chat rooms.”

Saldivar drew connections between the modern case and older testimonies of occult exploitation, referencing the book *He Came to Set the Captives Free* by Rebecca Brown. He quoted stories of infiltration and spiritual attacks that skeptics dismiss. “People laugh at us in the Christian world and say, ‘You’re crazy, Isaiah. [You think Satanists are putting curses on food and objects and jewelry?](#)’ Yes. Yes.”

He said what Christians often write off as coincidence or natural illness may have deeper origins. “Everybody would look at life as just normal, but not realizing the satanic roots, the satanic underbelly,” he reflected. Saldivar argued that believers must stop ignoring the unseen realm. “We cannot be ignorant to this. We need to have eyes that are open.”

According to Saldivar, when believers’ spiritual perception awakens, their lifestyles and priorities shift dramatically. He summarized what he believes will happen when Christians begin recognizing unseen evil:

- They will start actually praying.
- They will begin praying over everything that enters their homes.
- They will closely guard what their children watch and consume.
- They will get serious about God rather than casual.
- They will stop being naive about what their kids encounter online.

Saldivar said this case is not an isolated tragedy but evidence of an escalating battle for the souls of children, families and nations. “These levels of evil, guys, that are happening in our world right now are unfathomable,” he said. “Do not turn a blind eye to it.”

He ended his remarks by urging Christians to engage in spiritual warfare and protect their households. “We’re blowing the trumpet. You need to do deliverance. You need to cast the demons. You need to get serious because this stuff is happening.”

The case was not just a criminal matter but a spiritual alarm bell. “It is sickening,” Saldivar said. “Let’s open up our eyes to the spiritual realm around us and recognize that this is all real.”
