OFFICIAL “PROMOTION” RULES

Limitations on Eligibility/Availability of Charisma Media Sweepstakes” (“Promotion”).

Timing

How to Enter

Register during the Promotion Period by providing email address and name through the Facebook form hosted on the Charisma Media Facebook Page at and share through one of the designated share channels. Additional shares will increase the chances of winning. No purchase is necessary to participate in the “Promotion.” One (1) entry per person. Duplicate entries will be void. By entering the “Promotion” users agree to become a member of the Charisma Media email lists and to receive communication.
