

Exposing the Big Lie About COVID-19

In his book *Mein Kampf*, Adolf Hitler explained the concept of the “big lie”:

In the big lie there is always a certain force of credibility, because the broad masses of a nation are always more easily corrupted in the deeper strata of their emotional nature than consciously or voluntarily. Thus, in the primitive simplicity of their minds, they more readily fall victims to the big lie than the small lie, since they themselves often tell small lies in little matters but would be ashamed to resort to large-scale falsehoods. It would never come into their heads to fabricate colossal untruths, and they would not believe that others could have the impudence to distort the truth so infamously.

In other words, the basis of the Nazi nightmare was the telling of lies so large and so over the top that regular people could not imagine that someone could lie so massively. In this way, they would believe the big lie.

The Centers for Disease Control and Prevention finally released the data on COVID-19 from Feb. 1 to Aug. 22 and came to the astounding conclusion that “for 6% of the deaths, COVID-19 was the only cause mentioned.” This news came amazingly, seemingly without any introspection that 94% of all people who died from the virus died from another cause and not solely because of the virus.

The cause of death were varied, but included “respiratory conditions such as influenza and pneumonia, respiratory failure and respiratory arrest, as well as circulatory conditions such as hypertensive diseases, cardiac arrest and heart failure, sepsis, diabetes, renal failure and Alzheimer’s

disease,” all the information taken from death certificates and finally totaled. The CDC continued to call the report “the most reliable source of data” while telling the deceptive story that as of Monday, the U.S. has surpassed 6 million coronavirus cases and 183,000 deaths. This means that for all these months, as many have believed, other than a small percentage of deaths, nearly all the coronavirus deaths were in fact not caused by COVID-19 at all but by preexisting conditions.

Bestselling author of *God, Trump and COVID-19* Stephen Strang says, “I believe around the time of Passover, we’re going to see [the virus] really slow down, but I believe in the midst of this, there’s a divine reset. There’s a recipe for awakening.”

“For nothing is secret that will not be revealed, nor anything hidden that will not be known and revealed” (Luke 8:17).

After six months of terror in which average citizens cowered in fear, afraid to go outside or talk to other people, their lives destroyed and businesses shut down, it turns out that, while of course there is an actual coronavirus, it only took 6% of the lives it was reported to have taken. More deaths came from unrelated causes than from the actual virus itself.
