

Watch Live: Day 3 of Judge Gorsuch's Confirmation Hearings

President Donald Trump's nominee to succeed the late Associate Justice Antonin Scalia on the Supreme Court, 10th Circuit Court of Appeals Judge Neil Gorsuch, will sit down for his third and final day of testimony before the Senate Judiciary Committee at approximately 9:30 a.m. EDT.
