

13-Year-Old Hospitalized After Doing What She Was Told

Note: Savannah spent her 13th birthday in the hospital, thanks to the COVID jab. Pfizer tried to tell her mother the poor child was “a mental patient,” even as their drug was robbing her daughter of the use of her legs.

Now LA County will mandate that all children 12 and up must get the COVID shots in order to return to school. Read on to learn more and help us fight for these children.

Savannah was a typical all-American girl, who worried about little else than doing well in school and hanging out with friends. But that was before the COVID shot.

Savannah's symptoms began within just hours of taking the jab. Her mother was told the symptoms would go away in 72 hours. But as Savannah's hands and feet went numb, and the tachycardia (rapid heartbeat), extreme blood pressure swings and bloody urine set in, her mother knew something was very, very wrong.

Emergency room doctors and Pfizer officials refused to admit it was their shot slowly killing little Savannah, even as skin began blistering and peeling off her appendages, and she began experiencing 10 or more seizures per day. Instead, they treated her like a “mental patient,” says her mother, and referred the poor child to a psychiatric ward. Meanwhile, Savannah lost the use of her legs.

Several months later, Savannah has learned to move again with the help of a walker. Her halting gait as she moves across a room stands in contrast to the jumping, running, giggly girl she was just months ago ... before the shot.

Los Angeles County has announced that unvaccinated children

will not be allowed in schools beginning Jan. 1. With more than 600,000 mostly Latino and Black children, the district is the second-largest school system in the country. California is now forcing parents to choose between their children's education and their lives.

Liberty Counsel is aggressively fighting to prevent repeats of Savannah's tragedy.

We are being deluged with desperate cries for help, like the one from Diane, whose daughter is being kicked out of school for not having the jab. As devout Catholics, Diane's family is opposed to the shots. Additionally, her daughter has already had COVID, and she has a genetic condition—both of which would make it extremely dangerous to take the jab.

But the school doesn't care that the shot could kill Diane's daughter—they're kicking her child out of school anyway. And Diane, like so many *thousands* of others, is begging Liberty Counsel for help.

A growing number of people now know and understand the dangers of these COVID jabs, the manufacturers of which skipped the 7-10 years of safety testing the shots should have received.
