Due to the message mentioning the persecution of Christ during Holy Week and Trump enduring trials around the same time, a media storm of accusations claims that Trump is comparing himself to Jesus.

While some argue that Trump's legal woes are self-inflicted, many of his supporters believe there is a political witch hunt taking place against the former president to keep him out of the White House.

The majority of the post comes from Psalm 109:3-8, which is a "Plea for Judgment of False Accusers." Trump has claimed to be fighting similar persecution from the inception of his legal problems.

*The 9th US Circuit Court of Appeals sided with the former president in his effort to recoup additional legal fees from adult film star Stormy Daniels, who had filed and lost a defamation suit against him.*

*Daniels was ordered to pay Trump's attorneys just over \$120,000 in legal fees. That's on top of the more than \$500,000 in court-ordered payments to Trump attorneys she's already been ordered to pay.*
